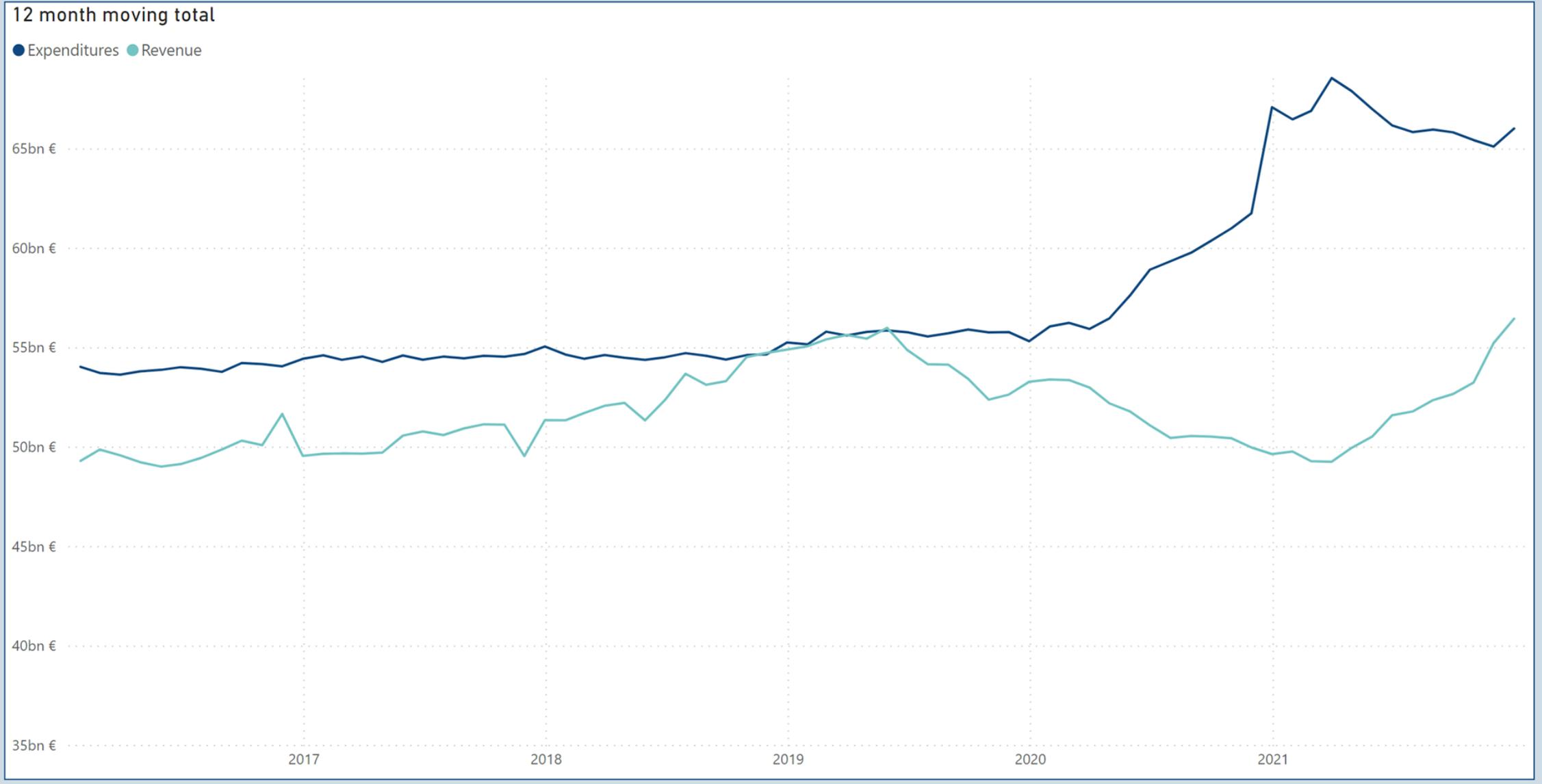

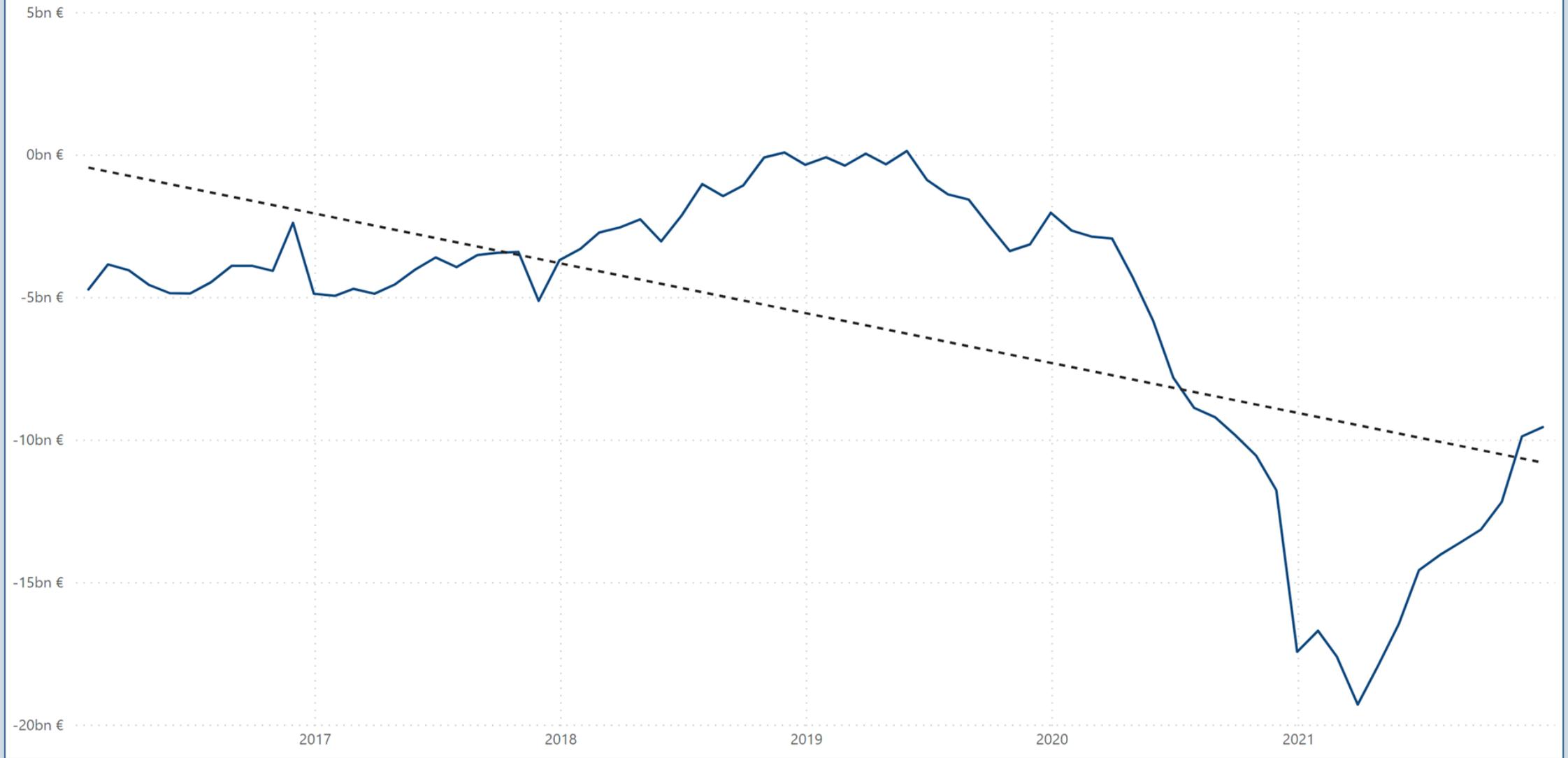

12 month moving total and linear trend



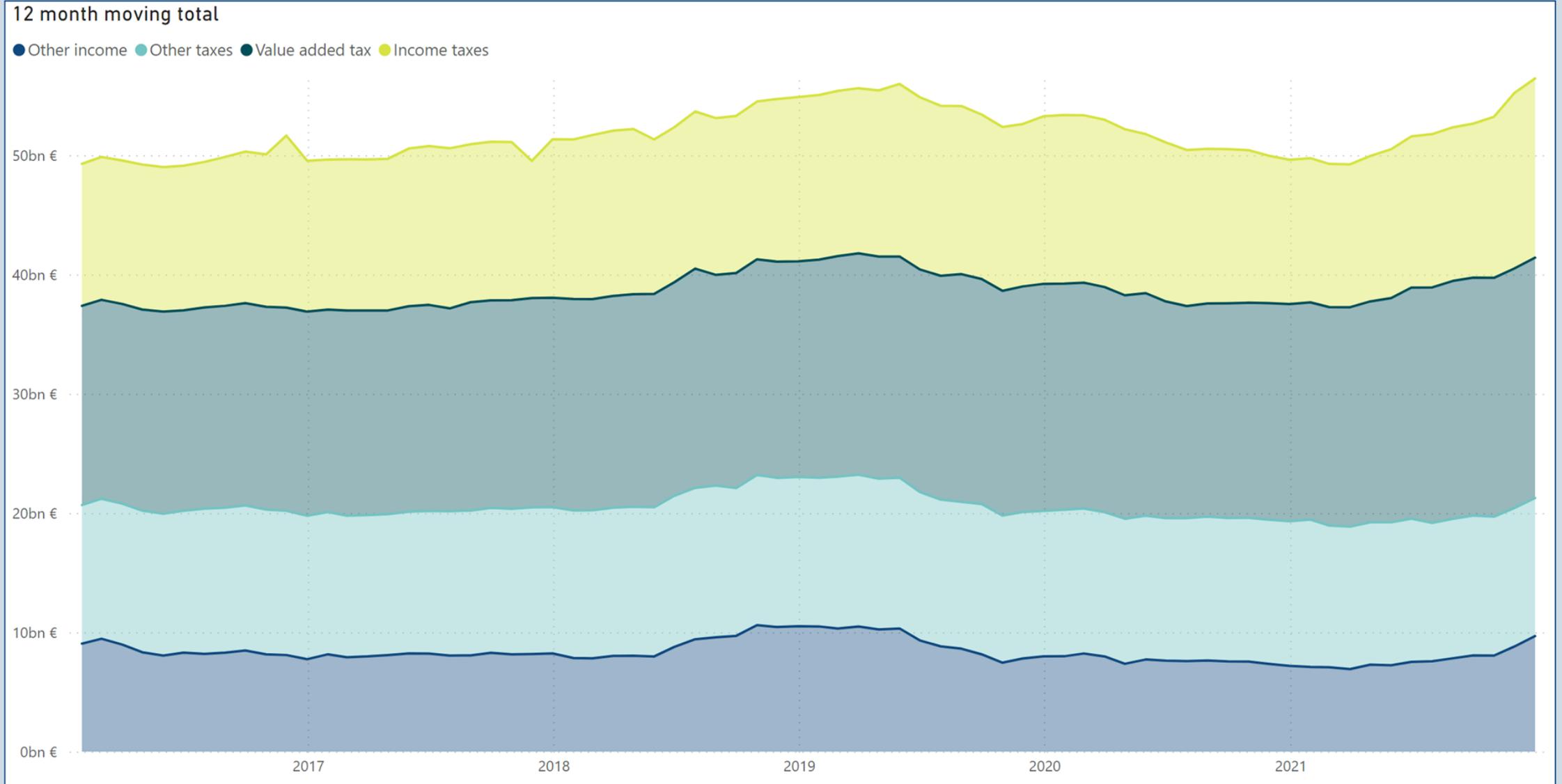

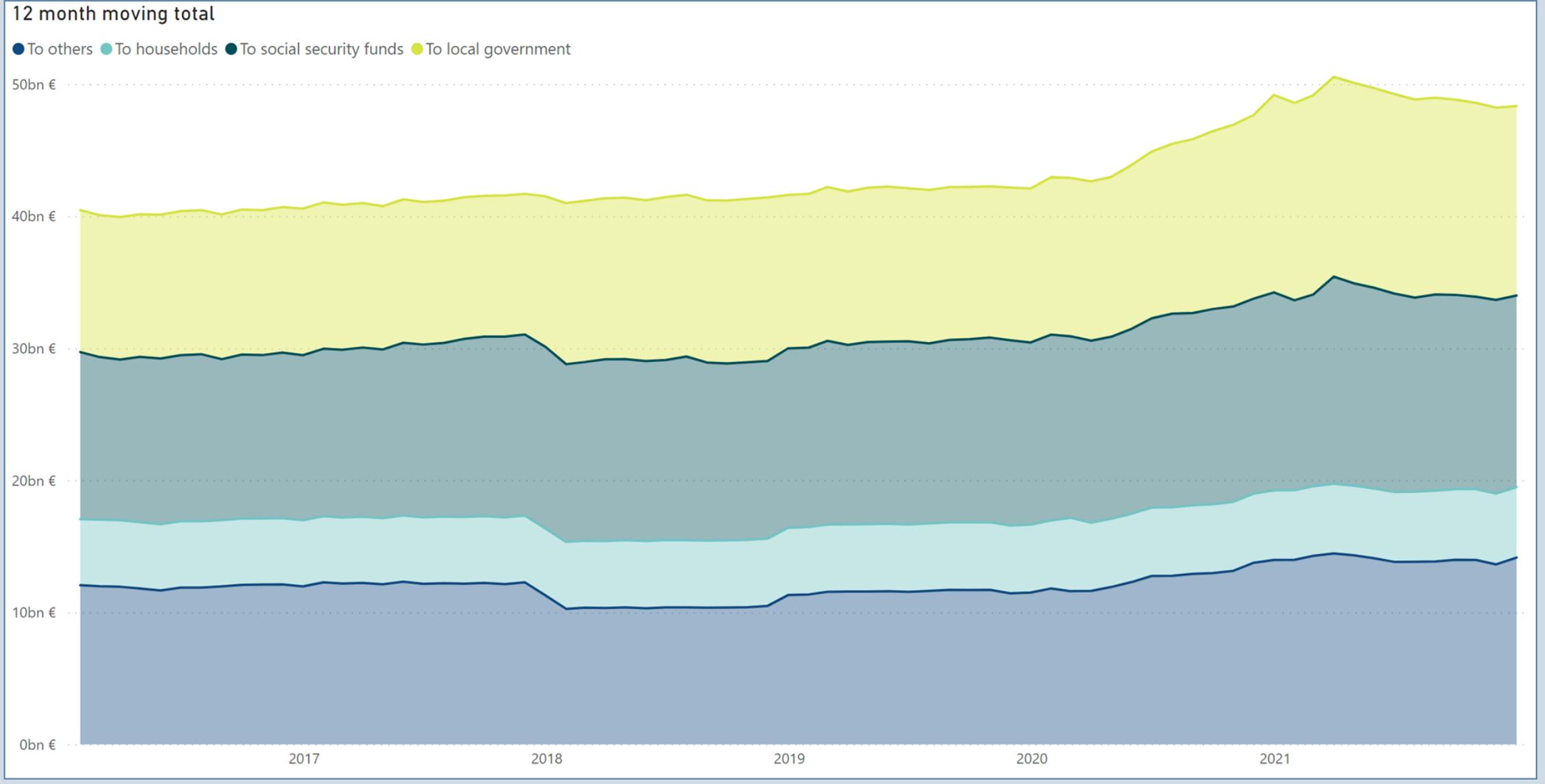

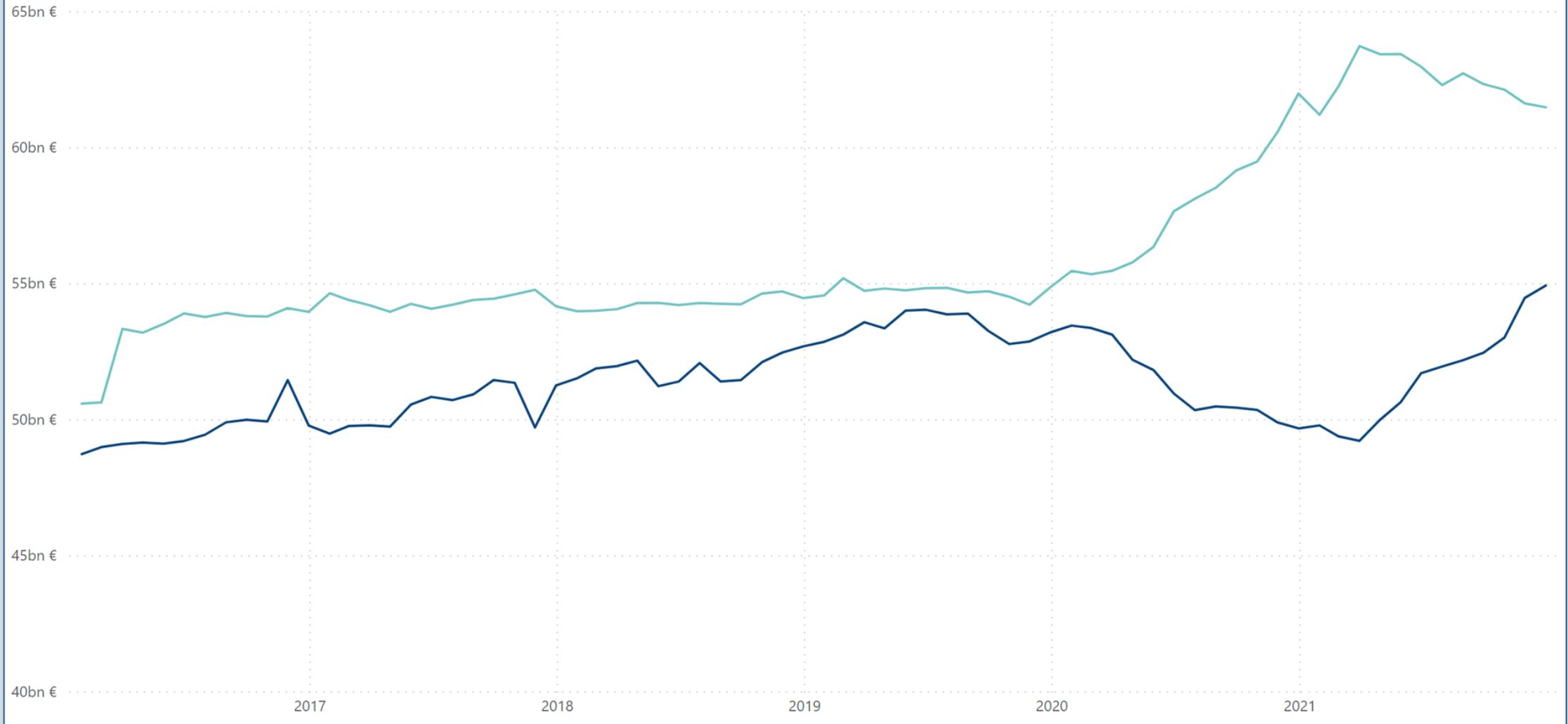

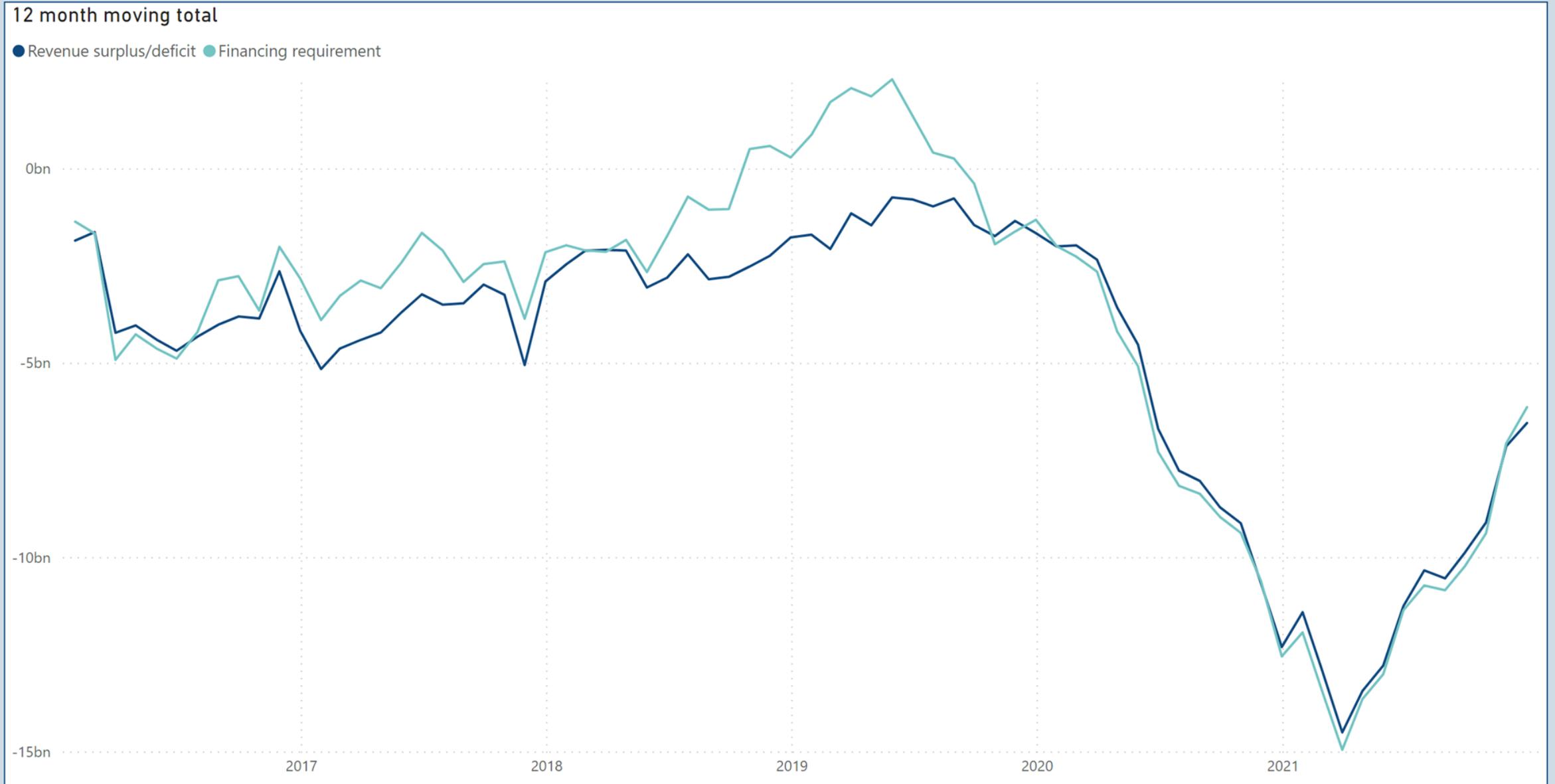

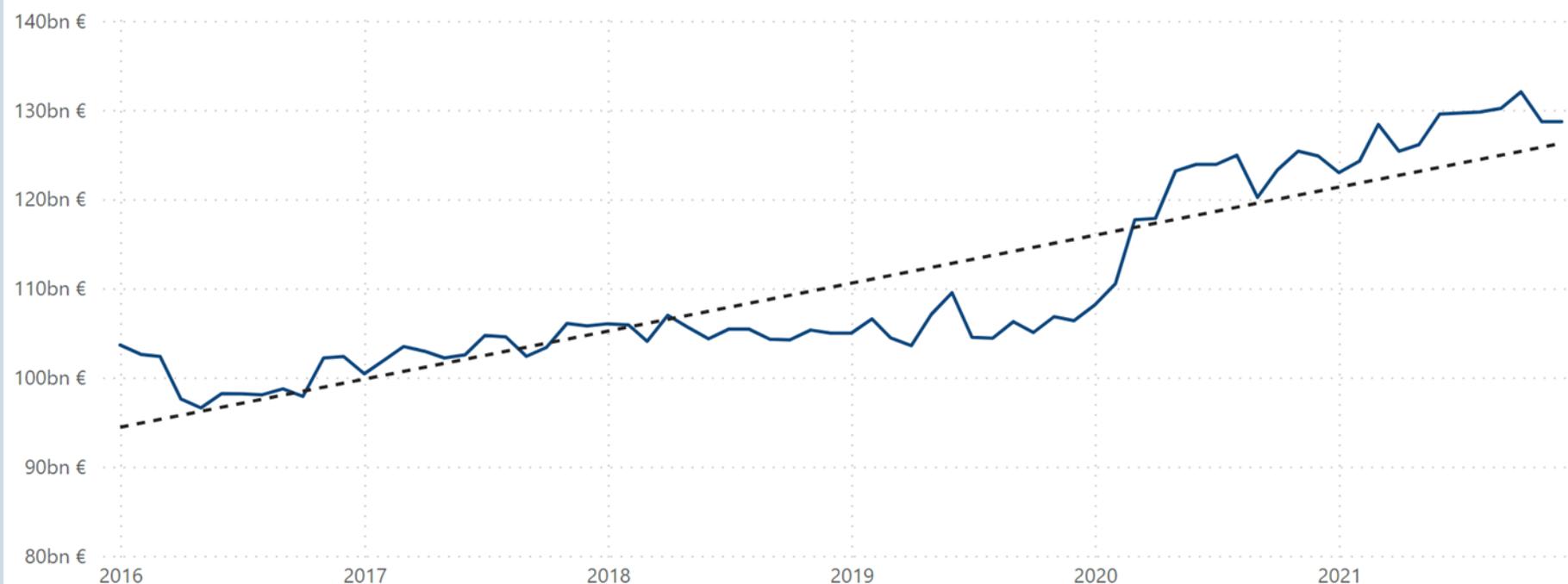
